The Definition of Chinese Diaspora

Chinese Diaspora

- Chinese diaspora, are known as "Hua Qiao Hua Ren"(华侨华人) in Chinese.
 - "Hua Qiao" (华侨), or "overseas Chinese", are citizens of China who are living abroad.
 - "Hua Ren"(华人), or "Chinese overseas", are foreign citizens who are Chinese by descent and ethnicity.

- The number of Chinese diaspora continue to expand
 - At present, the number of Chinese diaspora is more than 60 million, located in 198 countries and regions around the world, with more than more than 30 million return overseas Chinese family members living throughout China.

- The demographic structure of Chinese diaspora community has changed significantly, with young generations of ethnic Chinese becoming the mainstay.
 - The number of students going abroad is gradually increasing. According to Ministry of Education, from 1978 to the end of 2019, a total of 6,560,600 students of various types have studied abroad in China, of whom 1,656,200 are studying or researching at relevant stages abroad; 4,904,400 have completed their studies. Of those who have completed their studies, 4,231,700 have chosen to return to China, while others have obtained long-term residency outside of China, and some have joined the nationality of their host countries and become new Chinese diaspora.

- The educational and economic status of Chinese diaspora has been further strengthened, which lead to more active participation in academic, cultural, business, and political activities.
- At the same time, the Chinese diaspora still retains its Chinese ethnic and cultural identity and maintains strong ties with its home country.

- Chinese citizens living overseas (Hua Qiao) are subject to China's domestic policies;
- Chinese descendants who are citizens of other countries (Hua Ren) come under China's foreign affairs.

- National Immigration Administration (NIA) is an initiative long advocated and promoted by Center for China and Globalization (CCG).
- Since its establishment in 2008, CCG has been focusing on issues related to international migration, assisting relevant ministries to carry out research on improving visa and permanent residence policies.
- In 2016, CCG's proposal on the establishment of a national immigration bureau was approved by leaders such as Xi Jinping and Li Keqiang.
- CCG undertook the first major research project since its establishment.

- Promoting international student and staff mobility
 - The Opinions put forward that efforts should be made to break down institutional barriers, increase the reform of Chinese-foreign cooperation in running schools, improve the operation of universities outside China, reform the foreign affairs approval policies, and continue to promote the reform involving students studying abroad, students coming to China, foreign experts and foreign teachers.

- Attracting Overseas Chinese High-Level Talents
 - The "Overseas Chinese High-Level Talents" mainly refers to overseas Chinese talents who have obtained doctoral degrees and titles above associate high level, including experts and scholars who hold positions above associate professor in famous universities and research institutes abroad, professional and technical talents who hold positions above senior level in internationally renowned enterprises, entrepreneurial talents who have independent intellectual property rights and are familiar with relevant industrial fields and international rules, as well as other innovative and entrepreneurial talents urgently needed and in short supply in the country.

From the Management Measures of National Overseas High-Level Talent Introduction Program[国家海外高层次人才引进计划管理办法]. 2017

- Relaxation of application requirements for permanent residence
 - Before: Chinese overseas working in China, with doctoral degree or working continuously in China's key development areas for 4 years and actually living in China for not less than 6 months per year, can apply to the Exit-Entry Administration of the public security authorities for permanent residence in China. Their foreign spouses and children can apply with them.
 - Now: Chinese overseas with a doctorate degree can apply for permanent residence in China simply by submitting relevant documents, without meeting any requirement on previous working time.

- Supporting overseas Chinese language education
 - Promoting Chinese language education is an important way to enable new generation of Chinese diaspora to learn and understand Chinese culture and pass on Chinese spirit.
 - Developing Chinese language education according to the actual situation in different countries and regions.
 - Realizing the goal of providing proper books, access to schools and qualified teachers for young Chinese descents who wish to learn Chinese in areas where Chinese diaspora live. ("实现海外侨胞聚居地区有意愿学习中文的华裔青少年有书读、有学上、有合格教师的目标")
